
## Dear Patron:

The 5th Regiment Virginia Infantry was organized May 7, 1861, with twelve companies, A to M, and accepted into the service of the Confederate States about June 80, 1861, with eleven comparies. A to L. Company B was assigned to the 4th Regiment Virginia Infantry as Company K from about July 3 to July 24, 1861, when it was transferred to the 27th Regiment Virginia Infantry and became(2d) Company H. Company L appears to have served as artiller; from about October 31, 1861, until April 17, 1862, when the company was feorgalized and returned to the regiment. Company M was disbanded June 16, 1861. The regiment was reorganized April 21, 1862.
